## A Letter From Our CEO

As the sense of anticipation grows to put Covid -19 behind us, we still must be vigilant

Looking back at April 2020 and comparing things to where we are now, it's encouraging to see just how far we have come in one year since the Covid-19 pandemic. Although it's not completely behind us, hope is on the horizon with the rollout of the vaccine and millions already vaccinated. # **Good News!** Covid Cases are Majorly Declining in Long-Term Care Facilities as Residents Receive the Vaccine

As the Covid-19 vaccine continues to be distributed and administered, long-term care facilities specifically are seeing a major decline in the number of new cases among residents and staff. Since mid-December, the number of Covid cases among residents in nursing homes has decreased by 89 percent, according to data from the Centers for Medicare & Medicaid Services (CMS). New resident cases are also at their lowest levels since the CMS began tracking data in May 2020.

In a recent interview on CNN, Mark Parkinson, who is the President and CEO of the American Health Care Association and National Center for Assisted Living (AHCA/NCAL) which represents 14,000 long-term care facilities across the country, attributed the positive data and news to the success of the vaccine. Parkinson mentioned in this interview that just a couple of weeks ago,

there was a peak of 30,000 new Covid cases reported each week. Since the vaccine rollout, those numbers have dropped to 3,000 new cases a week, and for some providers, they are now seeing zero new cases. "It's absolutely astonishing; we all thought the vaccine would reduce cases, but I don't think any of us thought we would have zero cases," Parkinson said on CNN.

According to a press release from AHCA/NCAL, the Association has taken the lead in a nationwide goal to vaccinate 75 percent of the approximately 1.5 million nursing home staff by June 30, 2021. Long-term care facilities have made positive strides since the start of the pandemic. It's paramount that the most vulnerable population and frontline caregivers and providers continue to receive the vaccine so Covid cases decrease, and the virus is defeated for good.

## **Safe and Socially Distanced Activities for Your LTC Facility**

As the number of Covid cases continues to decrease from the vaccine, using safe and socially distanced practices is still paramount until more of the population receives the shot. Long-term care facility staff have worked tirelessly to ensure the safety of their residents throughout the pandemic. On top of residents' health and safety, LTC staff has also implemented extremely creative ways to keep spirits up and minds engaged during this time. We wanted to offer a couple of ideas for fun, socially distanced activities to try with your residents.

- 1. **In-room scavenger hunt -** Put those magazines to use! Create a list of items to search for and pass out magazines for residents to find, cut out, and make a collage of their findings. A prize can be given to the person who finds the most items.
- 2. **Bingo**, **with a twist -** Instead of gathering in a large room, have residents play doorway bingo. This would require setting up their chair and a side table by the doorway but it offers some across-the-hall interaction. A staff member can be in a central location to call out the letters and numbers.
- 3. **Plan a sundae social -** An ice cream party will excite people no matter their age. Residents can gather in their doorway while staff members come down the hall with a cart to help people prepare their favorite sundae. The sweet treat and socialization will definitely bring smiles to all.

# CDC Releases New Covid Guidelines for Fully Vaccinated People

New recommendations are released from the US Centers for Disease Control and Prevention stating that fully vaccinated people can safely visit with other vaccinated people and small groups of unvaccinated people in some circumstances. "Fully vaccinated" according to the CDC means people who are two weeks past their second dose of the Moderna and Pfizer Covid-19 vaccines or two weeks past the single dose of the Johnson & Johnson vaccine.

While the new guidance does not directly address what this means for long-term care or elder care facilities, the new CDC guidelines do state that grandparents who are fully vaccinated can visit indoor with their unvaccinated children or grandchildren without wearing masks or physical distancing, if none of the family members are at risk for severe Covid-19.

While the numbers are growing daily, nearly 38.3 million Americans are fully vaccinated, which represents 11.6% of the population, according to Our World in Data.

The new guidelines from the CDC state that fully vaccinated people can:

- Visit other fully vaccinated people indoors without wearing masks or physically distancing.
- Visit with unvaccinated people from a single household who are at low risk for severe Covid-19 disease indoors without wearing a mask or physical distancing.
- Skip quarantine and testing if they have been exposed to someone who has Covid-19 but is asymptomatic.

People who are vaccinated should still take precautions such as:

- Wear a mask and practice physical distancing in public, when visiting with unvaccinated people who are at an increased risk for severe Covid-19, and around people from multiple households.
- Get tested if experiencing any Covid-19 symptoms.
- Avoid medium-and large-sized in-person gatherings.

Federal data shows that about 4.6 million first doses and 2.5 million second doses have been given thus far to residents and staff in long-term care facilities. Approximately 5 million residents are living in nursing homes and assisted living facilities, and 1.5 million people working in nursing homes, according to AHCA/NCAL.
