August is National Immunization **Awareness Month**



National Immunization Awareness Month (NIAM) is an annual observance held in August to highlight the importance of vaccination for people of all ages. Communicating with your long-term facility patients and staff about NIAM and the importance of being vaccinated can protect them from serious illness and disease. Below are essential messages from the Centers for Disease Control and Prevention to use when discussing vaccination with your LTC patients.

Here are some key points to help your staff ensure that facility residents are up-to-date on their vaccines.

- Talk to your adult patients about missed vaccines and assess vaccination status at every visit.
- It is especially important for patients with health conditions to be up to date on their vaccinations since they are at increased risk for complications from certain vaccine-preventable diseases.
- Be a champion for vaccination in your facility by ensuring all staff share a consistent message with adult patients about the importance of vaccines for their health.

Vaccines can prevent life-threatening diseases and most adults aren't aware they need them.

As the healthcare provider to your patients in residential homes, your recommendations are appreciated, valued and trusted. Using this **SHARE** approach can help educate patients to make informed decisions about vaccination.

SHARE the tailored reasons why the recommended vaccine is right for the patient given their age, health status, lifestyle, or other risk factors. **HIGHLIGHT** positive experiences with vaccines (personal or in your healthcare experience), as appropriate, to reinforce the benefits and strengthen confidence. **ADDRESS** patient questions and any concerns about the vaccine, including side effects, safety, and effectiveness in plain and understandable language. **REMIND** patients that vaccines protect them and their loved ones from many common and serious diseases. **EXPLAIN** the potential costs of getting the disease, including serious health effects, time lost, and financial costs.

Here's why vaccination is so vital:

- Every year, thousands of adults in the US become seriously ill and are hospitalized because of diseases vaccines can help prevent. Many adults even die from these diseases.
- Adult vaccination rates are low in the US.
- · Adults with chronic conditions like diabetes or heart disease are at greater risk for severe complications from certain vaccine-preventable diseases. Some vaccine-preventable diseases, like flu, can make glucose control more difficult for diabetics or increase the risk of another heart attack for those with heart disease.

Flu Vaccines Available as Soon as This Month



Flu vaccines will become available at the end of August and beginning of September. You should get a flu vaccine by the end of October. However, as long as flu viruses are circulating, vaccination should continue throughout flu season, even in lanuary or later. Here are some **important factors about the flu vaccine** from the Centers for Disease Control and Prevention.

- The flu vaccine prevents illnesses, medical visits, hospitalizations, and deaths.
- Flu vaccination also is an important preventive tool for people with chronic health conditions. For example, flu vaccination has been associated with lower rates of some cardiac events among people with heart disease.
- Flu viruses are constantly changing, so flu vaccines may be updated from one season to the next to protect against the viruses that research suggests will be common during the upcoming flu season.
- Your protection from a flu vaccine declines over time. Yearly vaccination is needed for the best protection.

New Anti-Seizure Medication Available at Hudson Regional LTC Pharmacy

Rufinamide, the generic, non-brand name for **Banzel**, is now available at Hudson Regional LTC Pharmacy. This seizure medication is also called an anti-epileptic or anticonvulsant. Rufinamide, the generic version of Banzel, has been approved by the FDA. Banzel is used together with other medication to treat seizures caused by Lennox-Gastaut syndrome.

Ulster Green Arc Switches to Hudson Regional LTC Pharmacy

The Challenge:

Faydra has worked in the New York State Office for People With Developmental Disabilities (OPWDD) field for more than 21 years. For the past 11.5 years, she has worked as the Director of Nursing where she oversees four counties, including 29 RNS and 8 LPNs, and 1,500 developmentally disabled residents throughout the region's 59 residential programs.

Creative Solutions:

We really tried to make our previous pharmacy work but our transition with Angelo and Hudson Regional LTC Pharmacy was seamless and so helpful. Over my career, I've had three experiences with transitions of pharmacies but this transition was smooth as silk. All of the staff has been supportive and helpful; they're in it for the right reasons.

We gave them the information, they uploaded the data, and we didn't have to do anything. Their staff coordinated with each house, and they tweaked things as it was needed. They did such a wonderful job, we didn't have any issues with medications being missed, and they didn't hold things up. They go above and beyond to ensure the individuals have what they need.

Our total transition time from our previous pharmacy to Hudson took about a month and a half and this was in the month of December around the holidays. The other pharmacy was not gallant in any way, and they were not gracious in helping. Hudson Regional LTC Pharmacy stepped up and helped us to make sure no one went without medications or treatments. They have carried us along to this day.

The communication with Hudson Regional LTC Pharmacy from the pharmacists, to the staff, everyone seemed to be on the same page, whether it's from Angelo to the receptionist, everyone knows what the system is and gives me the same answer. The Hudson Regional LTC Pharmacy staff is a well-oiled machine in terms of what their processes are; they are clear, concise and they follow it. That enabled us to have a seamless transition.



Above & Beyond:

What makes Hudson successful is because their mission and priority is the individuals. It's not about the amount of money being paid back from the insurance companies.

They are supporting people who have a genuine need for these medications and it would be to their detriment if they don't get them. They work with us and we work with them. It's a symbiotic relationship to get the individuals served.

Another way Hudson Regional LTC Pharmacy goes above and beyond is helping individuals be as independent as possible with their abilities for self medication and administration. For example, prior to switching to Hudson Regional LTC, we told Angelo and his team that we have a resident that is legally blind. We work with this patient to help them be independent with taking their medications because they want to be. Before we even signed a contract with Hudson, Angelo went out and purchased a machine to make blister packs and put together options for tactical touchpoints (furry, bumps, brail) to help this one patient independently take their medication.
