Currently, at Hudson Regional LTC Pharmacy, our training nurses offer this 32-hour course to staff members who work for the agencies and homes we serve. Adapting this training to a remote learning environment is just another opportunity to meet the needs of those we serve.

The remote AMAP training course format will be offered in eight 4-hour sessions. This gives greater flexibility for agency staff members to attend, and eliminates the need to commute. To mask or not to mask?

Over the past two years, the mass population has been wearing a face mask to help slow the spread of COVID-19. This preventative measure has become a part of our daily lives. We have all been faced with so many unknowns; it started with how the virus impacts people to learning about symptoms from different variants, guarantine protocols, and the effectiveness of masks. Research is constantly studied and published as we know more.

A new study published this past February by the Centers for Disease Control and Prevention shows by the numbers how wearing a mask indoors has been linked to lowering the odds of testing positive for COVID-19. This study spanned over ten months, from February to December 2021. In this match casecontrol study, 1,828 people wore a cloth, surgical, or respirator (N95/KN95) mask.

This study showed that people were less likely to test positive for COVID-19 if they wore a mask indoors than people who didn't. Even though most mask mandates are lifted, people continue to protect themselves by wearing masks. If you're wondering which type of mask will help protect against testing positive for COVID-19, here is what the study found.

Meet Shannon! She has worked at HRLTCP for 2 years.

What is something you like most about Hudson Regional LTC Pharmacy? HRLTCP takes customer service to the next level. They make sure customers get taken care of, and if there is a problem, they tend right to it. Also, they ensure that everything is accurate and customers are satisfied.

What does a typical workday look like for you?

At our pharmacy, we create an order, and all prescriptions are filled based on a label. If that label doesn't get printed and slotted into the correct delivery desk, everything falls apart. There is a lot of importance placed on this process when it gets to packing.

I sort prescription labels to make sure each prescription gets out on time. I check run times, medication, prescription strength and highlight different quantities for a person. For example, someone might have to take one tablet twice daily. So I help make sure they know to take it two times daily. I print the labels, I sort them and put them on the prescription bottle, and separate medications into different piles. We do this for about 2,100 prescriptions per day.

How it Works Our Web Portal is very user-friendly, and we provide a lot of resources, so staff members have support along the way. We have a full step-by-step guide document with screenshots and best practices for using the Portal. Our team also offers live training on using the Portal to ensure everyone feels comfortable using the system. Here's a brief overview of portal functionalities.

Dashboard

After logging in, staff members have a dashboard view to manage orders, view patients, access E-MAR and E-MedPass status, send messages, and access reports.

New/Discontinued Medications

Nurses or other agency staff members can easily view new or discontinued prescriptions. For example, you can see if a prescription for a new medication has been communicated to the pharmacv. Discontinued medications are also verified here. Verifying discontinued medications assures medication administration records will not contain extraneous or obsolete information.

Pending/Processed Orders

The guesswork is taken out with our Web Portal. It displays in real-time if an order is pending and once an order is processed at our pharmacy. There is also a setting where nurses can view pending/processed medications for individuals or a group at a facility.

Patient's Profile

Each patient's profile includes vital and detailed information, including drug interactions and allergies. Nurses can also view or print prescription copies, access drug information, and see all active medications. Medical records, order status, and inactive medications are also displayed in a patient's profile.

Refills

All it takes is a couple of clicks to request a prescription refill! There is a prescription refill due report where staff can process weekly refills. Once submitted, there is an instant notification that the refill requests have been successfully sent.

These are just a few of the many features of our Web Portal. The HRLTCP team offers ongoing training for when your facility hires new staff members or if someone needs refresher training.
